ORDER OF PERMANENT INJUNCTION

The Plaintiffs, Kent Christon and Ryan Martin d/b/a Jammer Direct and the Jammer Direct Partnership ("Jammer Direct") having filed their Motion for Permanent Injunction, and the Court having conducted a hearing on June 29, 2012 on said Motion, and having examined the same and being otherwise duly advised in the premises,

It is hereby **ORDERED**, **ADJUDICATED** and **DECREED** that Defendant, Dan Vargas ("Vargas") is permanently enjoined with respect to the following:

- 1) Vargas shall refrain from taking any future action regarding Jammer Direct, LLC, or otherwise interfere with Plaintiffs' use, control, or management, if any, of Jammer Direct, LLC;
- 2) Vargas shall not create any new entity using the name Jammer Direct or any confusing similar variation;

- Vargas shall cease and desist from representing to any person, firm or entity that Vargas is an officer, employee, or owner of Jammer Direct, LLC or any confusingly similar entity;
- Vargas shall refrain from the use or infringement upon the trade name or any trademarks, copyrights or websites owned by Kent Christon, Ryan Martin, or Jammunity, LLC; and
- Vargas shall refrain from posting, contacting or otherwise interfering with any of the websites owned or operated by Kent Christon, Ryan Martin or Jammunity, LLC.

It is further **ORDERED**, **ADJUDICATED** and **DECREED** in accordance with I.C. 34-26-1, *et seq.*, that Vargas is permanently enjoined from engaging in any of the above-listed conduct and that Vargas is subject to sanctions if he willfully disobey this Order.
